

**CRITERIA FOR SOLIDARITY FUND
APPLICANTS**

Standing Order # 6
February 2003

1. The Solidarity Fund:
 - a) is established to subsidize **travelling expenses** to the General Assembly for delegates from National Communities in need of financial support.
 - b) is to be used for only **one** delegate per National Community until such time as representation from all Nationals is assured and monies are available for more than one subsidy.
 - c) will be available for **one** delegate from each "Observer Status" National Community in need (who meets the "eligibility criteria") with the proviso that the priority of representation from each member National Community has been satisfied.

2. The eligibility criteria for applicants depends on:
 - a) the establishment of a Preparation Team for the General Assembly,
 - b) having met the deadline to submit names of Preparatory Team to the Secretariat,
 - c) having made a reasonable effort to financially support the National delegate's expenses,
 - d) the National Community being in good standing regarding the payment of yearly dues to the world Community.

3. In the event of surplus monies:
 - a) a second delegate from National Communities in need may be subsidized
 - b) a supplement be offered to subsidize delegate registration for National Communities in need.
